
Carbon Offset for Event Management


Emissions rise from different human activities, as well as energy consumption, agriculture, development and expansion of industries, transportation, deforestation, cooking and waste. All the activities also relate to organizing events, and notably, the problem has worsened over time.





Principles of Carbon Offset







Hosting a carbon-neutral event not only helps to reduce greenhouse gases, but also helps to practice social responsibility.

This activity promotes competitiveness of industries like Thailand's MICE Industry in order to fulfill customers' requirements by organizing a Carbon-Neutral event, the current major trend for event management.

Moreover, businesses obtaining carbon credits from emission reduction program in Thailand can inspire other concerned parties and project developers to introduce more emission reduction projects and activities, leading to more reductions in Thailand.



Benefits of Carbon Offset for Event Management

Encourages social responsibilities among public and private sectors as well as MICE operators.

Promotes better understanding of carbon offset activities in event management to all relevant stakeholders.

Methodology for GHG measurements in an Event



1st Category


Direct GHG emissions from services, tools or equipment owned by an event organizer who is responsible for the operation costs:

1

GHG emission from energy consumption (with proper combustion) that is a responsibility of an organizer such as in LPG consumption when cooking


2

Preparation of food and beverage for an exhibition



2nd Category

Inirect GHG emissions from consuming purchased electricity, steam, heating and cooling:



GHG emissions from purchased electricity, steam, heating and cooling during an event and venue preparation throughout the exhibition period.





Other **indirect** GHG emissions beyond the scope of the 2nd category:

1

CO₂ emission from domestic and international transportation of participants, which includes travelling by car, by bus, by train, by plane, etc.

2

CO₂ emission from staying in the city where the event takes place.

Exhibition materials: ${\rm CO}_2$ emission in acquiring raw material, producing and shipping of any exhibition materials should all be taken into account when calculating the emission.

2

CO2 emission from waste, generated by conferences, management: storage, shipping and waste disposal system should be accounted for too.











Procedures for Arranging Carbon Offset Activity in an Event consist of 2 periods:-

1 Before the event


- **1.1** Download the application form at http://carbonmarket.tgo.or.th and submit the completed form to TGO: Thailand Greenhouse Gas Management Organization (Public Organization)
- 1.2 Measure GHG emission deductively: calculate the estimated amount of emissions generated by an event by considering its program or budget that are in line with TGO standards. To download Carbon Footprint for Organization (CFO) Calculator, simply go to: http://thaicarbonlabel.tgo.or.th
- 1.3 Contact a credit provider to purchase the right amount of carbon credits calculated according to the deductive method mentioned in 1.2. Then, contact those who responsible for credit cancellation in order to retire the credit. For the list of carbon offset providers, please visit http://carbomarket.tgo.or.th
- **1.4** Submit the transaction log and cancellation document to TGO.
- 1.5 Relevant documents and evidences will be checked by TGO: once completed, TGO will grant the requester the right to display "Carbon Neutral Event" logo to promote the event.

2 After the Event

- **2.1** Calculate the emission amount by using actual data collected from the event in line with TGO standards. Download the Carbon Footprint for Organization (CFO) Calculator at: http://thaicarbonlabel.tgo.or.th
- 2.2 Contact and submit the calculation report to a verifier a person in charge with carbon footprint verification for an organization as well as an event operation that has been registered with Thailand Greenhouse Gas Management Organization (Public Organization) for verification purpose. For the list of verifiers, please visit http://thaicarbonlabel.tgo.or.th/
- **2.3** The verifier certifies the verification report and submits it to TGO.
- **2.4** TGO proposes the report to the Technical Committee in order to grant a certification to the event.

If the amount of GHG emission calculated by the deductive method is less than the actual emission, it is necessary to offset more car bon credits until they completely cover actual emission. In addition, this process must be done within 3 months after the event.

Procedures for Organizing a Carbon Neutral Event



Contact a credit provider to purchase a certain amount of carbon credits with reference to the deductive calculation method.

Submit a transaction log and cancellation document to TGO.

TGO authorizes the use of Carbon Neutral logo for PR purpose.

Organize an event or a conference.

If the amount of purchased carbon credits completely cover actual emission.

TGO certifies carbon offset activity of the event.

Arrange a Technical Committee meeting for certification.

Expenses of carbon offset activity for an event

Expenses depend on different factors such as size of an event, event period, number of participants, type of transportation for participants.

Activity	Cost
Carbon Footprint Calculation	Follow the template of TGO (no cost)
from an event	Hire a consultant 1, approximately 10,000-15,000 Baht/1 Man day
Credit offset	approximately 200 Baht/ carbon dioxide ton
Cost of using Carbon Neutral logo	TGO's support (no cost)
Cost for verifiers	approximately 10,000-15,000 Baht/1 Man day
Request for certification	TGO's support (no cost)
Estimated cost/activity	10,000-40,000 Baht

^{1 &}quot;Consultant" means an expert who is able to give consultation in an area of a corporate carbon footprint of organizations and event operations. Thailand Greenhouse Gas Management Organization (Public Organization) provides a list of experts so that entrepreneurs, based on an advice given, can choose a consultant to corporate carbon footprint of organizations and event operations.
